- 1. Apologies for Absence: Apologies were received and accepted from Mr Beresford and Mr Drummond.
- 2. Declaration of Members' Interests: No interests were declared.
- 3. <u>Public Participation:</u> A neighbour to Farleys read a statement objecting to the application. She gave explanation to her objections which related to over development of the site, impact on neighbours, potential for overlooking, proximity, trees and proposed materials. The Chairman thanked her for her comments.
- 4. New Planning Applications: The following applications were reviewed and discussed. Application details had been circulated in advance of the meeting and were also displayed:

After careful consideration, members agreed that the Parish Council had no objection to the principle of extending the property but objected to this application as the increase in extent and bulk of the property was significant and contrary to Neighbourhood Plan Policy DS3. |

- a. Land South of Meadowbank (Great Meadow): CDC's Enforcement Officers were now following up on contractor's parking around the Green and the sales office entrance. Clerk to advise CDC.
- b. AB asked what was happening with the Winterfold House as the site currently looked unsightly. AJ confirmed that the site did have planning permission for a new house and that the work had been started prior to the expiry of the permission.
- c. The Clerk advised that West Sussex County Council was pursuing the legal route to remove the travellers on The Green.
