	The planning circumstances, policy and decisions, previously made by CDC and the Planning Inspector for a residential property, have not changed and are also relevant to this application. Although the creation of additional office space is desirable in this Parish, the Parish Council does not consider this to be a suitable location, being isolated office space in a purely residential area. The Parish Council is concerned at the suitability of the access and with the provision of 4 parking bays, neighbouring properties could experience increased traffic movements and disturbance.

	The office accommodation does not require this rural location, is behind the current building line and is not linked to any of the surrounding properties. The Parish Council believes that this application is contrary to Local Plan and Neighbourhood Plan policies.
