Chairman's Message

Please can I start with a sorry/not sorry: the decision to drain the Green was not taken lightly, not only would it be an expensive job but it would lead to substantial disruption. When the idea of installing a drainage system in the Green was proposed, Wisborough Green Sports obtained advice on which system to install and the potential for side effects. Simply, the Green is mainly clay (hence the perpetual waterlogging and the need to drain it) and this presents special problems. Once the drainage cassettes were installed and filled with sand, which is how the drains work, if a particularly dry period were experienced the clay would shrink, the sand fall into the spaces created and trenches appear – this is exactly what happened, creating a real hazard.

By the time you read this the trenches will all have been filled and, when the time is right, grass seed will be sown. Whilst we are all very sorry about the appalling state of the Green this summer, we are sure it will be great in the years ahead. More inside.

It's wonderful to see the Green so busy on Friday evenings, what a fabulous village asset the Green is. This in turn has led to parking concerns, particularly around the Butts Meadow junction, which we have taken up with WG Sports.

The first meeting in May includes the election of Chair and Vice-Chair. I was delighted to be elected again as Chair, but it may have escaped your attention, the PC has a new Vice-Chair, Sophie Winship. Sophie has made, and continues to make, a huge contribution to the village. She is taking over from Andrew Jackson, who has been a Parish Councillor since the days of compulsory archery practice on the Green (mud permitting). Andrew continues to serve the PC and the village where his immense experience and sound judgement are invaluable.

The Jubilee weekend was a resounding triumph, bringing the village together for a four day celebration. I would like to lead the thanks to WG Sports and St Peter's for all their hard work in pulling it together.

The transfer of the Songhurst Meadow title to the Parish Council is being finalised. If you haven't yet been, go and have a nosey. Songhurst Meadow will be a wonderful adjunct to the Green for dog walking, walking, running or just chillin'; the 750m circular path should be completed in the autumn. Trees have been planted as part of the Queen's Green Canopy and a Field Maple for the Platinum Jubilee. I need to extend thanks to the Stride family who have been diligently watering the trees; without this more of these trees would not have survived.

As I write, we are in the middle of a glorious heatwave, the Green is being topped up again and again (the clay keeps shrinking) and we look forward to the August Bank Holiday Monday Fete.

Gatwick Airport

Village Green Drainage and Levelling

Wisborough Green Sports, and the Parish Council, recognised that undertaking such a large project would have an impact upon general recreational use of the Green as well as sport, however short-term disruption would have a long-term gain. Unfortunately, the completion of the project has been affected by the dry weather this year; after the grass seed was sown in the drainage channels in the spring, there was insufficient rain for germination, and the dry spell has continued. It was known that the channels would settle and top up would be required, but the very dry weather has resulted in further settling as the clay has shrunk. Work has already been undertaken to top up the channels and will continue as needed.

In preparation for the football season, further seeding will be undertaken and irrigation undertaken as necessary. The weather has worked against us, but Andy Burbridge (member of the drainage project group and also a Parish Councillor) has given his assurance that it will be available for the football season and there will be a marked improvement on the previously waterlogged ground.

The Parish Council will continue to support Wisborough Green Sports in bringing this important project to fruition.

Can we please remind you that you can start cutting hedges again from September without fear of disturbing nesting birds.

Landowners have a responsibility to cut roadside hedges; it's important to keep road signs visible and allow cyclists and pedestrians space to move off the road. Likewise, clear pedestrian access, especially for those with wheelchairs, pushchairs and mobility scooters, is important, so please cut back vegetation bordering pavements. Thank you.

Traffic Speed and Noise - the latest

Petworth Road Traffic Regulation Order: The application for a speed reduction to create a 40mph buffer zone on the west side of the village has been successful and the application is currently in consultation, supported by Sussex Police. Most evidence suggests that this will help to reduce traffic speed within the village 30mph zone. Fingers crossed for success and that it will be implemented by WSCC in the near future.

<u>Durbans Road Speed Reduction</u>: We have now followed up our unsuccessful application with WSCC Highways. By making a Freedom of Information request, digging deeper into the process, and generally making a nuisance of ourselves, we identified that our County Councillor, Janet Duncton, withdrew her support; we were disappointed with her response and recently invited her to meet Parish Councillors who were able to highlight their disappointment about Mrs Duncton's lack of support and candour. We are aware that recently there was another accident on the corner and will ask WSCC Highways to review the signage and, in the future, reconsider our application.

Durbans Road Residents – if there are further accidents, please phone the police and get the incident recorded, however minor; new evidence will assist any further application.

<u>Community Speed Watch (CSW):</u> The village team have held 41 Speed Watch sessions since the beginning of the year; logging over 700 offenders on the Police-led Community Speed Watch website – so they're still getting out there on a regular basis despite the dwindling numbers.

A bit of background – we can only operate sessions with Police prior knowledge and approval. We do this by logging our intended sessions on their website. We can only operate at Police-approved sites within 30 and 40 mph limits. We have several locations around the village but tend to concentrate on the A272 that has the greatest impact on the village with regard to noise and safety. Once a session is completed we log our results and leave the rest up to the Police.

If you are concerned about the speed of vehicles where you live then join the team and we can get a site approved near you. Our volunteers usually carry out just a couple of hour-long sessions a month, and fewer during winter months.

Speed Indicator Device: At long last WG's SID is on order. You will shortly see 'SID' at 7 locations around the village, for up to 3 weeks at a time. All village residents will be required to elicit a smile from SID.

School Traffic: With the start of a new school year in September, the Parish Council has produced a flyer, to be distributed to all parents and included in the September Ad Vincula. It highlights the



voluntary one-way system in School Road, identifies the village car parks and addresses parking and speeding concerns. Your support would be much appreciated.

Pond Re-Pointing

This work was originally planned for last September, but the contractor let us down. We now have a different contractor arranged to complete the pond refurbishment in September when the water is a little lower and hopefully warmer. He will be donning his waders and working waist deep in water to rake out the old mortar and re-point. This work is not just for appearance but to ensure the structure is sound for years to come.

War Memorial

The War Memorial is showing its age, and why shouldn't it – it was installed in Spring 1921 at a cost of (old money) £168. 12s. 4d, supplied by G Maile & Son, Euston Road, London. Part of the base and lime mortar has failed so the memorial will shortly be cleaned and repaired.

Project Gigabit - no progress to report

We had hoped that the WSCC Officer responsible for the Gigabit rollout in West Sussex would attend our July meeting, but he has postponed until September/October when he hopes to have more information.

The reason for this delay is that the Department for Digital, Culture, Media and Sport has had some slippage in delivering against its Project Gigabit milestones. In West Sussex this means that they continue to design and finalise an intervention area that will be eligible for public subsidy having analysed the plans of the commercial telecoms market. This also means that the Voucher Scheme remains paused in West Sussex until we are notified.

We are sorry that there is no further positive news, but we will keep pushing on behalf of the village.

School Admissions

It has been brought to the Parish Council's attention that new residents, or those considering a move to the village, are unable to secure school places at Wisborough Green School. This is a concern and one that we have highlighted to CDC, on more than one occasion, in relation to further development in the village. We are now taking the matter up with WSCC that has responsibility for school admissions. We'll report any developments.

Songhurst Meadow Open Space - take a look

We are delighted that most of the new homes are now occupied, some by existing village residents but also those new to Wisborough Green; the Parish Council extends a warm welcome to you all. We are sure that you will enjoy this wonderful village and hope that once settled, you will fully immerse yourself in village life.

The legal agreement to transfer ownership (and maintenance) of the open space land to the Parish Council has now been completed and we look forward to creating an open space that is more rural and not another formal village green. Wildflowers, trees, long grass and enhancements that improve and promote wildlife and nature have been included; although some junior cricket may be played it is not intended to be a formal sports area. The installation of a perimeter(ish) track, planned for September, will make this area accessible to all, and will hopefully encourage more of us to run/walk that mile a day (two circuits is an Olympic Mile).

Immediately inside the entrance from Durbans Road there is a car park for use by anyone visiting the village or for school runs. A short and pleasant walk takes you straight through to Newpound Lane opposite the school – children can run freely without traffic worry, so please use this car park to ease congestion around the school.

Neighbourhood Plan – dare we say we're getting there?

The Wisborough Green Neighbourhood Plan Review is nearing the end of the review process and is currently undergoing a 'Health Check' by an external advisor, to ensure that it meets the Basic Conditions and National Planning Policy Framework requirements.

The review process and policy amendments have had to tread a fine line between its intended purpose of protecting the integrity of the village and passing examination, enabling it to be 'made' (adopted) by CDC.

The NP Review team has worked extremely hard to achieve this milestone, over a period of <u>years</u>, and all in spite of the complications that arose due to the continuing delay of the Chichester Local Plan Review.

We will continue to keep the community updated as the reviewed Plan goes through its final stages.

CDC's Subsidised Tree Scheme is now open

District residents, landowners, farmers, community groups, businesses and other organisations, can apply for these trees, as long as the site is suitable. This scheme is funded by HM Treasury's Shared Outcomes Fund, and covers 50% of the cost of the trees, with applicants contributing the remaining 50%. CDC has five different bundles available, depending on where the trees are being planted, plus a hedgerow bundle. Each bundle contains 10, 20 or 25 trees and people can apply for up to 20 bundles.

You must be aged 18 or over, an elector, and have been a resident or worked within 3 miles of the Parish for the past year. The position is unpaid.



Major Emergency Plan - Can you help in a time of need?

The Parish Council has a plan in place which provides simple guidance to support our emergency services or, if appropriate, to start a self-help response in the event of a major incident in the village (available on the village website).

A 'Major Incident or Emergency' is an endangering of, or likely to endanger, life and property event that would be beyond the scope and facilities of normal day-to-day operations of an inter-agency response.

In normal circumstances the response to a major emergency would come from the Emergency Services, Chichester District Council and West Sussex County Council. Sussex Police would probably take the initial lead in co-ordinating the operation. In these circumstances the Parish Council will assist with local knowledge, as requested. However, as has occurred in the past, self-help and a community response maybe required when the emergency services and outside agencies are unable to attend. The scenario envisaged is widespread travel disruption and blocked roads caused by severe weather, with potentially damaged, uninhabitable homes and injured parishioners. The Parish Council will take the lead in whatever initial steps are possible, however, these circumstances would have to be exceptional and should not be confused with uncomfortable situations experienced with short-term power loss!
