

### The Parish Council Year from May 2022 to April 2023

## Chairman's Report

At the time of writing my introduction last year, we were all in shock at Russia's invasion of Ukraine and yet to experience the effect on our own lives from this appalling conflict. I understand it is an odd measure, but we are already onto our second Ukrainian flag on the village green; I hope the war is over, and Russia expelled, before we need to replace the flag again.

It has been an interesting year; the major projects being the handover of the Songhurst Meadow open space to the village and the construction of the, exactly half-mile, track around the perimeter, and completion of the village green drainage. The former is absolutely delightful and it's wonderful that some parents are parking in the public car park and walking to the school. The latter was not without controversy however I think we can claim a win. Despite a wet winter, football was played throughout and the green appears in great overall condition, ready for the impending cricket season. Provided we don't experience another exceptionally dry spell we can hope that the trench shrinkage that blighted last year will be consigned to history.

It's important to remember that the green is for more than just sport; walking, picnics (please take your rubbish home), dog walking (please bag and bin your pooch's offerings) or just chillin' in the sun. The green is the village's beating heart and critical to making WG the quintessential, beautiful English village that it is.

Maintaining that status is one of the Parish Council's key priorities which brings me onto the CDC Local Plan and the WG Neighbourhood Plan. When the revision/ updating process for both of these was begun in 2018, WG was allocated 25 new homes on top of the 68 we had delivered in the Plan's first iteration. In 2020 this number was increased to 40 and then at the last gasp, in January this year, 75. As far as I can tell, for CDC this is just a quantitative exercise (numbers) with lip service being paid to the qualitative aspects of their proposals (aesthetics). The threat of development on Glebe Fields hasn't gone away (the application was withdrawn not refused) and be under no illusion as any development there will be a gateway to development of 80+ homes in the future. My view, this would change WG forever.

There are, as usual, many people to thank, however I would like to single out the Neighbourhood Plan Review Team who keep going, despite setbacks and changes and, in two cases, having moved from the village – that's how special WG is... and, of course, Louise, without whom the wheels would fall off.

## Some High and Low Moments from the Year

- Title to Songhurst Meadow Open Space transferred to the Parish Council. We have a fabulous new recreation area complete with circular exercise path. Official opening held.
- CDC advised in January 2023 of an increase in the Local Plan housing allocation, 40 to 75. An 11 page response was submitted to the Local Plan consultation to raise village concerns.
- Frustration that this increase impacts upon progress of our Neighbourhood Plan Review stalled again.
- Following the 'Young Lives Matter' survey in December 2021, plans have been made to enlarge the cricket net surface to provide a permanent basketball and 5 a-side-goal. Coming soon.
- No news from CDC about the planning application for the new Pavilion.
- Councillors agreed on the design for a Parish Council logo.
- Our Speed Indicator Device arrived and was put to good use. A real low, it was stolen from Newpound Lane in March.
- The pond restoration project was completed. The wall is now secure for many years to come.
- Remembrance Day road closure managed by Parish Councillors and the Clerk; it was quiet for the 2 minute silence.
- Two community litter picking sessions held; great turnout.
- WSCC Young Offenders' Scheme undertook village maintenance.
- Signage for the 40mph buffer zone on the A272 west side of the village installed; the SID proved that it is reducing speed.
- Unwelcome visitors on the village green in August a stressful time.
- Frustration that the goal-posts keep being moved for funding a Village Broadband Scheme but we haven't given up!
- One small Horse Chestnut removed. Sadly surveys confirmed that two large trees need to come down due to internal decay.
- Publicans generously provide Warm Spaces this winter.
- No interest in the Parish Council vacancy since July 2021. Non contested election in May 2023 and we now have a full house.



## Money Matters - Income for year ending 31st March 2023



**Total Income - £149,563:** Not including money transferred into the budget from the Reserve Funds.

Precept - £70,000: Increased by £3,000 on the previous year.

Section 106 Funds - £55,000: A legal agreement from Runnymede Homes.

**Donations - £9,729:** Runnymede Homes also donated £8,000 towards the new path, WG Sports contributed to additional drainage sand, and bench donors paid for the purchase, installation and maintenance of benches.

**Village Hall Lease - £7,686:** Paid every 6 months and covers the loan repayments for the Old Workhouse refurbishment.

**Allotments - £696**: Charged at 25p per square metre per year, increased to 27p from 1<sup>st</sup> April 2023. A £30 deposit is taken to encourage plots to be left in a good condition.

**Grant Funding - £5,628:** Received for the Neighbourhood Plan and used for consultant support; £619 unspent funds were returned.

**Bank Interest- £398:** Up from £11.39 on the previous year. A 1-year Fixed Term Deposit Account was opened with £30,000 in January. It is the intention to open further accounts with £30,000 every 3 months.


**Public Toilet Donations - £360:** From the Fete Society, School PTA, and the Fair (the fee was waived as the Fair was re-located) toward the upkeep, with thanks.

**Sundry Income - £66:** Relates to peppercorn rent and the Fete Society garage rent.

Allocated Reserves - £12,131: Bought into the budget and used for the pond, Speed Indicator Device, noticeboard, new path and a drainage project refund to WG Sports.

CIL Reserve - £10,845: Used for the new path and Speed Indicator Device.

## Money Matters - Expenditure for year ending 31st March



#### Total Expenditure - £118,360

Administration - £37,753: The total annual cost which includes the Clerk's salary, insurance and all other expenses that allows the Council to function efficiently.

Included in Administration are Section 137 donations totalling £470. Applications from outside village organisations were considered and the PC agreed donations to St Catherine's Hospice (£50), Kent Surrey Sussex Air Ambulance (£100), Chichester & Arun Citizens Advice (£50), 4Sight Vision (£50), Billingshurst Emergency Assistance Team (£100) and Remembrance wreaths from the Royal British Legion (£100). A floral tribute for the late Queen was also purchased.

**Village Maintenance - £23,467:** The Parish Council is responsible for general village maintenance to preserve the village's appearance. Village maintenance includes work to the green, tree surgery, litter and dog bin emptying, post installation, verge repairs, dog waste bags, grass cutting, ditching and general maintenance items. It also includes an allowance for Winter Management which of course wasn't used this year.

This figure also includes the CDC annual cost of emptying 16 litter bins and 2 dog waste bins weekly ( $\pounds$ 2,038) as well as the annual cleaning cost and supplies for the public toilets ( $\pounds$ 6,768). With Songhurst Meadow open space being transferred to the PC, grass cutting, tree surgery, posts and fencing costs were incurred.

**Allotments - £837:** The PC continues to maintain the allotment hedge and addressed some health & safety and security concerns on the site. The water bill was higher due to the hot summer.

## **Money Matters - Expenditure Continued**

**Neighbourhood Plan - £5,780:** We received £5,009 grant funding to fund consultants to offer help and advice, the majority being spent on a report to support a Local Green Space designation; £771 was spent from the budget.

**Songhurst Meadow Path - £24,273:** This was a major expenditure but is now providing a well used circular path which also links Newpound Lane and Durbans Road. It was funded with a donation from the developer (£8,000), Section 106 Funding (£5,818), Community Infrastructure Levy Funding (CIL) collected from the Songhurst Meadow development (£9,000) and £1,455 from the budget. CIL is ring-fenced within the PC's reserves and can only be for projects identified to support a growing village.

**Speed Indicator Device - £4,183:** Funded from New Homes Bonus (£2,338), received from CDC and held in reserves from the previous year, and CIL (£1,845).

**Pond Project - £3,350:** Re-pointing of the brick walls was the final part of the project delayed from the previous year. It was funded from New Homes Bonus held in reserves ( $\pounds$ 2,227) and budget provision ( $\pounds$ 1,123).

**Use of Other Reserves - £1,717:** Funds were held over from the previous year for a new noticeboard (£1,015) and to refund WG Sports for the drainage project (£702).

**Other Projects - £4,526:** Includes expenditure for the Jubilee celebration band (£500, a deposit for the new youth surface to be installed when the ground dries up (£1,250) and the new goal/basketball net (£2,745).

**Loan Repayments - £8,236:** A low interest loan was taken out in 2012 for the playground refurbishment and in 2016 to cover the cost of the Old Workhouse refurbishment. The PC makes annual repayments and for the Workhouse this is covered by the Lease payment received from the V Hall. The last playground payment was in November 2022. The last repayment for the Workhouse is November 2023.

**Village Donations - £1,550:** The PC continues to support village organisations and was pleased to contribute £300 to the Community Minibus Association and made a donation of £1,250 to St Peter's PCC towards the grass cutting and clock maintenance.

Village Benches - £932: This cost is reimbursed by the donors.

**Chairman's Allowance - £109:** Used to buy refreshments for the Annual Parish Meeting and a leaving gift for the Village Hall Chairman.

Village Hall - £135: Electrical connections for the new committee room screen.

**Unbudgeted Expenditure - £1,512:** Relates to new committee room chairs (PC meetings were getting very uncomfortable!) and a projection screen to display reports. The Jubilee party on the green was such a great event and the band was asked to continue playing, incurring an additional £200 charge.
