Chairman's Message

When events that have happened before happen again, and again, in what seems exactly the same way they are known colloquially as 'Groundhog Day' moments. Wisborough Green Parish Council (PC) has a few Groundhog Day issues: parking, hedge cutting, picking up dog poo, traffic on the west road, planning directives from above, etc.; these keep reappearing on the PC's agenda and, despite attempting to address them, they all come back. It's the PC version of Whack-a-Mole.

Dogs, and what they (or rather their owners) leave behind is an issue which should <u>not</u> need to be revisited. I am a cynophile (a.k.a. a dog lover) and our three are some of our best chums; I would never leave their 'deposits' lying on the lawn, would anyone? Why-oh-why do some people not treat public spaces similarly? Observers on Songhurst Meadow explain that one reason, although not an excuse, is that walkers are so glued to their smartphones that they fail to notice when their dog(s) leave a steaming pile. Losing sight of your dog in the dark is another. Simply, this is unacceptable, especially so as we approach spring when more people will be out and about enjoying the Songhurst Meadow and the Green.

The PC has had a leaflet printed that emphasises the serious health hazard that dog faeces present, especially to young children, that could lead to blindness. Further, enforcement is being put in place capable of issuing a Fixed Penalty Notice carrying a £100 fine. Why is this even necessary? If you see someone failing to pick up after their dogs please report them confidentially on the number on the leaflet (a photograph would be helpful too).

The PC provides poo bags for those who may have forgotten to bring them, the dispenser was recently moved to the west road, in front of the Pavilion as, in its previous location, some car drivers were stopping to grab a handful – the PC expenditure on this was approaching £500 per annum. Don't get me started on people who pick up then hang the bags on trees or bushes; what is this madness?

In the southern French town of Béziers owners who leave dog poo in the street could soon be tracked down using a DNA database. A scheme is being trialled that requires dog owners to have their pets DNA tested allowing authorities to link them to excrement left on the ground. Under the scheme, dog owners will be required to take their pets to a vet for a free saliva sample, which will be DNA tested and a 'passport' issued. Those subsequently stopped without their dog's DNA passport will be fined €38 (£32.60). If we were able I would happily see such a scheme introduced in WG; I would happily name and shame the guilty parties whether inadvertent or repeat offenders.

Traffic Matters

The west road that leads to the Pavilion: It has been previously highlighted that many more cars are being parked and/or driven at speed along the west road. Access on this road is restricted to residents, pavilion staff and sports match officials. Different signs are currently being trialled and have already been altered to reflect concerns about turning. The PC is closely monitoring vehicle activity and asks that you support the endeavours on safety and protection of the village green. Any comments can be made to the PC Clerk either by phone or email.

<u>Community Speed Watch:</u> As usual, the Winter months offered the CSW team a bit of time off. However, they're gearing up for a Spring Offensive... in the hopes of keeping the village safer and, hopefully, quieter.

<u>Speed Indicator Device:</u> SID has been around the village in his various locations recording valuable data – which has been useful in supporting our application for a reduction in the speed limit along Durbans Road. We have heard from several residents that where SID's been located they've noticed a reduction in vehicle speed – he's doing good work.

<u>A272 Surface:</u> We, as a village, are collectively utterly sick and tired of the state of the main road through the village (A272). Numerous attempts at repair have been tried by the WSCC Highways teams – all to little or no effect. The PC has been relentless in highlighting the continuing problems to Highways and senior members of WSCC. It all comes down to money – the resurfacing of the main stretch is 'out to tender' for the current financial year. Fingers crossed we see some progress. In the meantime, it is vital we all report road surface damage – simply Google "pothole West Sussex" and you will be directed to the appropriate page of the WSCC website. Keep our roads top of their inbox.

<u>Durbans Road Speed Reduction:</u> The previous attempt to reduce the 40mph limit failed to meet WSCC criteria because the cars were going too fast (madness). WSCC recently changed its policy which has potentially opened the door for another application; the PC has just submitted a Community Traffic Regulation Order application, so here's hoping. You will obviously be kept up to speed.

Precept 2024 - 2025

This article first appeared in the January Ad Vincula magazine. Repeating in case you missed it.

CDC will shortly be sending out your Council Tax statement containing itemised charges for CDC, WSCC, Sussex Police and the Parish Council. The Precept, the local element of Council Tax, is the Parish Council's main source of funds and is used in maintaining and administering the village.

Over several years, our County and District Councils have had to focus budgets on social services and other statutory obligations. Many other services they provide, that we may normally see in our village, have now been reduced or withdrawn. Many of these services relate to general maintenance: gully clearance, road sweeping, sign cleaning, grass cutting, public toilets etc; things that if left undone, have a cumulative and detrimental effect for our village.

The Wisborough Green Precept will be increased for the coming year, funding additional maintenance by the Parish Council. The increase will represent less than £10/year for Band D households. It will help fund:

- Full maintenance for the public toilets in addition to cleaning, otherwise the facilities would be closed.
- Clearing road gutters and weed removal to keep pavements safe.
- Grass cutting costs and Songhurst Meadow open space maintenance.
- Resurfacing of the Kirdford Road pavement on the village green to improve width and remove trip hazards.
- Pothole repairs on Parish Council land.
- Playground equipment maintenance.

The Parish Council already has increases in existing costs, for example, looking after the village green and over 80 trees on Parish land. We know from feedback that residents value the village being looked after. Whilst it adds further pressure on our budget, we consider that items dropping off the WSCC/CDC lists should be maintained at village level, rather than not at all, risking safety and perhaps higher long term repair costs. We are not alone and other villages are taking this approach.

An increase of under 9% represents an 18p per week increase for a Band D property, and 36p per week for a Band H property, allowing the village to directly benefit. It means that the Parish Council can do more to protect, preserve and enhance Wisborough Green; more than would be the case if left to CDC and WSCC.

Allotments available - catch the allotment bug!

Was it your New Year's resolution to grow veg? This is your opportunity as there are currently two plots available. Priority is given to WG residents, but rather than have uncultivated plots, they will be allocated to other local residents if there is no WG demand. Public loos acquired by Wisborough Green

It's 10 years ago that the PC went into battle against CDC to keep the public loos open and a petition demonstrated the widespread support for retaining the facilities. After some negotiation, the PC entered into a 10-year agreement whereby the PC paid the cleaning costs and CDC picked up all other charges.

As mentioned in the article explaining the Precept, CDC has been looking at ways to reduce its budget and the WG loos came under the spotlight again. Last autumn, CDC offered to sell the facilities to the Parish Council, for £1.00, otherwise it was likely they would be closed. The PC decided the village couldn't take that risk, as they are valuable for residents, visitors, community events, the many delivery drivers serving the village, and those just passing through; this is demonstrated, not only by the emails of appreciation sent to the PC, but also donations from grateful travellers.

From 1st April 2024, the PC will assume responsibility, including all the costs, for the building. Hopefully the building will be updated in the future to provide disabled and baby changing facilities.

Parish Council Investments

One of the PC's roles is to ensure that your money is spent wisely and earmarked reserves are protected. Much consideration is given to the annual budget and with rising bank interest rates, the PC made the decision to invest funds in a series of smaller one year fixed rate bonds. These funds are covered by the Financial Services Compensation Scheme and the interest earned is supporting the village.

Hear all about it - Annual Report

Through articles in the Ad Vincula and this newsletter, the PC tries to provide an update on the projects being undertaken, however these only provides a summary of the work that the Council does. More details are available in the published meeting minutes, and a full Annual Report is published following the 31st March year-end.

For the last couple of years, we have circulated a summary of this report to every household in May and will be so doing again.

WHY DOG FOULING IS TOTALLY UNACCEPTABLE

- Dog faeces can pose a significant health risk, particularly to young children as their immune systems are not fully developed.

- All faeces contain bacteria that can cause stomach upsets, but the greatest risk is from toxocariasis.

Every child needs a family. Do you have room in yours?

You don't need to be a superhero to be a foster carer! You simply need to have some experience of caring for children, a spare bedroom, and be kind and patient (a sense of humour also helps!).

Every child deserves to have a safe and loving home, where they can experience all that life has to offer and fulfil their potential.

While the children that West Sussex County Council cares for are all in safe accommodation, a number are living a significant distance from their school and friends. 65% of these young people are aged 11 to 17 and they are waiting to find a local foster family – someone like you – to guide them through this important time in their lives.



There are many types of care, from respite (usually one weekend a month) to Supported Lodgings, where you can help a young person aged 16-21 learn the skills needed to live independently.

Foster carers for WSCC receive comprehensive training, ongoing professional support and a competitive financial package of up to £30,393 per year, per child.

One WSCC foster carer, James, stated, "To be the first person to give a child hope, or care, or love... is the most rewarding thing I have ever done in my life".
