5. Self and Custom Build:

AJ advised he had been contacted by telephone by a Loxwood resident who was promoting self and custom build homes. He claimed to have previously held a senior management position in a building company but had since retired. He had apparently encouraged Chichester District Council (CDC) to include a new policy in the Local Plan, Policy H6 Custom and/or Self Build Homes, details of which were provided. He appeared to want to encourage Wisborough Green to include a policy in its Neighbourhood Plan (NP). AJ had explained the NP review process, and that further consultation would be undertaken, which he was welcome to contribute to. He did not feel that further information or contact was required at this time. **Members supported this response.**
